Subject: FY 2012 & FY 2013 - Closing Schedule for Accounting Periods

Date: July 3, 2012

The monthly schedule for closing the accounting periods is changing effective with the June 30 (period 9) close. In the past, the accounting periods were closed around the 15th calendar day of the subsequent month. In accordance with the revised schedule, the accounting periods will be closed on the 7th business day of the subsequent month (excluding September/October). In order to adhere to the closing schedule, it is critical that monthly activity is recorded promptly and in the relevant accounting period, to the extent possible. As such, all monthly Banner Finance feeds must occur in accordance with the current feed schedule. In addition, journal voucher (JV) requests (related to non grant accounts) which are "date sensitive" must be submitted to Accounting by the required due date. JV requests which are not date sensitive will be processed in the current open accounting period. Please contact Sponsored Programs Administration regarding journal voucher request deadlines for grant and contract accounts.

The fiscal year 2012 (revised) and fiscal year 2013 closing schedules for accounting periods, including the due dates for the feeder systems and journal voucher requests for date sensitive transactions, are included on the following pages.
